We will be accepting applications starting January 3 through March 1, 2017. Recipients will be announced by April 27, 2017.


You're eligible to apply if you:

### **Volunteer as a Tax Preparer**

The Volunteer Income Tax Assistance (VITA), sponsored by United Way Silicon Valley, is a national program created by the IRS to assist low-income individuals or families with their taxes at designated sites. Volunteers also help tax filers find out if they are eligible to claim the Earned Income Tax Credit.

You can help your community and volunteer as a tax preparer, financial counselor or other important roles at one of the sites. As a volunteer tax preparer or reviewer, you will need to complete free training to receive your IRS certification before

tax season begins. All volunteers will be asked to commit some time during the tax season from January through April 14, 2017, and will be assigned a location within their community.
