Help Your Community and Volunteer as a Tax Preparer

Star One has once again teamed up with the Internal Revenue Service (IRS) to provide free tax assistance to low-to-moderate income individuals or families who cannot prepare their tax returns.

Your Help Is Needed

The Volunteer Income Tax Assistance (VITA) or the Federal Earned Income Tax Credit (EITC) program, sponsored by United Way Silicon Valley, is a national program created by the IRS to assist individuals or families with their taxes at designated sites.

You can volunteer as a tax preparer, financial counselor or fill another important role at one of the sites. You will receive professional IRS training as a tax preparer, tax reviewer or greeter. As a volunteer tax preparer or reviewer you will need to complete free training to receive your IRS certification before tax season begins. All volunteers will be asked to commit some time during the tax season from January through April 15, 2012.

Beware Property Tax Adjustment Scams

With home values stagnant or declining in some areas of California, it's not surprising that a proposal to lower your property taxes may sound appealing. But beware. If you receive a mailing that appears to be from an official-sounding agency (like "Tax Review" or "Tax Adjusters," "Regional Processing Center," etc.), it is very likely a scam targeting homeowners.

These fraudsters are claiming to help you lower your property taxes for a fee. They may also ask for your Social Security number. Some may say that you "aren't taking advantage of a special exemption under California law" and state some specific statutes that don't exist. Others may simply try to convince you that they can lower your tax bill when others can't. Still others may warn you that you will owe a fee if you don't respond. **Don't be fooled.**

• If a private company offers to try to lower your property taxes, their literature must clearly

state that they are not a government agency and that their services are not endorsed by any government agency. If they do not, they are in violation of California law. Even if they do disclose this information, you do not need to pay for an assessment or use a middleman.

- Government agencies do not charge for tax reassessments. If you think your property tax amount is incorrect, contact your county tax assessor's office and request a review of your property – for free.
- Do not send money for something you did not ask for, and do not reveal your Social Security number or other personal information to anyone who sends you an unsolicited mailing.
- If you have received an illegal mailing or are a victim of a property tax reassessment scam, file a complaint with the California Attorney General's office at http://ag.ca.gov/consumers/ general.php.
